Thank you for getting back to me. I have 3 questions arising from your response:

* Can you please provide us with copies of the certificates of compliance issued for Simons Pass Station?

* In relation to the properties where you are aware large areas of land have been developed but no certificate of compliance sought is the Council assuming that the exemption applies, or will it be following up to assess whether in fact a consent is required and this requirement needs to be enforced? If the Council is assuming the exemption applies will it be requesting applications for certificates of compliance?

* Has the Council received any further applications (other than Simons Pass) for certificates of compliance for clearance? Your final paragraph infers it has not but is not completely clear.

Dear Madeleine

Thank you for your letter of 22 March requesting information regarding the clearance of tussock grasslands.

The Mackenzie District Council does not know definitively how many properties have relied on the exemption to Rule 12.1.1.g to clear tussock grasslands, or the area cleared. This is because there is no requirement for the Council to be notified of any activities in relation to the exemption.

We do know that large areas of land has been developed on Simons Pass Station and that they have sought and been issued certificates of compliance in relation to their activities.

We are also aware that large areas of land have been developed between the Twizel

EIC of P Reaburn for EDS Appendix A - EDS & MDC email correspondence and Ohau Rivers, but no certificates of compliance were issued for this development. There has also been large areas of development on Rhoborough Downs Station near Twizel, and Mt Gerald Station near Lake Tekapo.

The Council does not know what further clearance will occur through to December 2016, however, I am not aware of any significant clearance of tussock grasslands proposed by any land owner.
